
Colorado Building Material Sales Selected Counties

First Quarter 2011


This issue presents data on Colorado building materials sales for the first quarter 2011. This report shows retail sales for each of the seven Denver metro area counties and for the counties of El Paso, Fremont, Garfield, La Plata, Larimer, Mesa, Pueblo, and Weld. The types of retailers included in the chart on the next page are home centers, paint and wall-covering stores, hardware stores, and specialized building material dealers. The period shown in this report is the first quarter of 2011 compared to the first quarter of 2010.

The graph below shows national versus Colorado retail sales. Nationally, sales of building materials increased 7.2 percent to \$59.79 billion in the first quarter 2011 over the first quarter 2010. Colorado's retail sales of building materials were \$819.2 million in the first quarter 2011, a 6.2 percent increase over the same quarter in the previous year.

Sales in the counties comprising this report increased 2.3 percent over last year. La Plata and Boulder counties recorded double-digit increases year-over-year, while Garfield and Broomfield counties incurred double-digit decreases during the same time period. All but four of the selected counties recorded positive growth.
