



LETTER FROM THE DIRECTOR

It's always great to be able to start the new fiscal year feeling good about the one that just ended. For the Colorado Lottery, there is a lot to feel good about. Each of our three pillar categories saw growth last fiscal year. Our revenue, responsibility, and conservation pillars were raised.

Thanks to the support of our players and retailers, the Lottery provided over \$195M to our beneficiaries out of this year's \$890M in total sales revenue. The gaming landscape in Colorado is changing, and it brings more challenges to playing responsibly. Beyond joining the small group of WLA4 certified lotteries, we are hiring a dedicated player health manager. For conservation, the projects that trigger the most emotion for me are all the tree clearing and fire mitigation efforts that have helped our state recover from its wildfires and slow fires in the future. I continue to be impressed, but not surprised, by the work of the Lottery team. I'm honored to lead this team, and proud of another stellar report card.
