I. Board of Trustees

The Board of Trustees, appointed by the Supreme Court, consists of five attorneys and two public members. The Trustees for 2009 were: Charles Goldberg, Chair, Charles Turner, Susan S. Riehl, Nathifa Lewis, Andy McCallin, the Honorable Ethan D. Feldman and Donald A. Pesek.

Charles Goldberg, Esq., Chair of the Board, is a partner in the Denver firm of Rothgerber, Johnson and Lyons, LLP, and a former Denver District Court Judge. Mr. Goldberg served for over 20 years on the Supreme Court's Pattern Civil Jury Instruction Committee and is a former member of the Board of Director of the National Client Protection Organization. Mr. Goldberg is also a Fellow of the American College of Trial Lawyers, recognized by Best Lawyers in America and as one of the "Colorado Super Lawyers". Mr. Goldberg is involved in several professional and community organizations.

Charles Turner, Esq., is the Executive Director of the Colorado/Denver Bar Associations. Mr. Turner is involved locally and nationally in professional organizations.

Donald A. Pesek is Manager of BID Operations for the Downtown Denver Partnership. He has been with the Partnership for 8 years and is most proud of his involvement with the growth and success of downtown Denver's Business Improvement District. He has applied over 30 years of experience in both construction and property management in the administration of the BID's clean and safe programs. Originally from the Cleveland area, Don has worked in HUD's property management and Indian Housing operations in Ohio and New Mexico, and has managed high-end condominium properties. He has a Business degree from The Ohio State University and a Masters of Public Administration from the Maxwell School of Syracuse University.

In addition to his normal duties, he has served as a sub-committee Co-Chair of Mayor Hickenlooper's Graffiti Task Force; on a number of committees for Denver's Road Home, the Mayor's homeless initiative; and also serves on committees dealing with downtown security and hospitality.

Honorable Ethan D. Feldman has been a judge of the Arapahoe County Court since February 1992 and has twice been Presiding Judge of the Court. His assignments have included preliminary felony matters, domestic violence cases and other misdemeanors, DUI's, traffic, and civil cases. He has also served as an acting judge of the District Court.

Judge Feldman is a 1970 graduate of Northwestern University in Evanston, Illinois with a degree in Russian Studies and is a 1974 graduate of the University of Denver College of Law. Prior to his appointment to the County bench, Judge Feldman was Deputy and Chief Deputy District Attorney in Arapahoe County from 1974 to 1980. He was in

private practice from 1980 to 1992 during which time he also served as a part-time municipal judge in Glendale for 12 years.

Judge Feldman is past president of the Arapahoe County Bar Association, a past member of the Board of Governors of the Colorado Bar Association, and past chairperson of the Criminal Law Section of the Colorado Bar Association. He is currently president of the Colorado County Judges' Association and the Colorado Trial Judges' Council. He has served on several committees of the Colorado Supreme Court.

Nathifa Lewis, Esq., is a staff attorney and the Director of Denver Prevention Partnership Project. Denver Prevention Partnership is a joint program with Denver Department of Human Services that helps strengthen struggling families at-risk of entering the court system. She trains and provides support to volunteer attorneys who are assigned to work with a family to help create a stable home, thereby sparing the children the trauma of being removed from their family. After earning her J.D. from the University Of Denver College Of Law, Nathifa served as Public Defender for 2 1/2 years before she joined the Children's Law Center in 1999.

Andrew P. McCallin, Esq., is a First Assistant Attorney General in the Consumer Protection Section of the Colorado Attorney General's Office.

Susan S. Riehl, is the Vice President and Chief Financial Officer for the Colorado Historical Society, State of Colorado.

II. Introduction

This annual report of the Colorado Supreme Court Attorneys' Fund for Client Protection (the Fund) covers the period beginning January 1, 2009 and ending December 31, 2009.

The purpose of the Fund is to promote public confidence in the administration of justice and the integrity of the legal profession by mitigating losses caused by the dishonest conduct of attorneys admitted and licensed to practice law in the courts of this state during the course of attorney-client or court-appointed fiduciary relationship between the attorney and the claimant.

The Fund does not receive any governmental monies or tax dollars. Every active Colorado attorney contributes twenty dollars to the Fund as a part of their annual registration fee. Effective January 1, 2008, the Supreme Court increased the annual assessment to forty dollars per active attorney. Additionally, the Supreme Court authorized a one million dollar one-time transfer into the Fund from the Attorney Regulation Counsel reserve.

III. History and Structure of the Fund

On June 25, 1998 (effective January 1, 1999), the Colorado Supreme Court established the Fund. Under the supervision of the Colorado Supreme Court, a Board of Trustees appointed by the Court receives, holds, manages and disburses the funds collected. *See* C.R.C.P. 252.2.

The Board of Trustees consists of five Colorado attorneys and two public members appointed by the Supreme Court. The Trustees serve without compensation and are appointed for terms of three years and are eligible to serve no more than two consecutive, three-year terms. *See* C.R.C.P. 252.5.

The Trustees meet as frequently as necessary to process claims in a timely manner. The Trustees, in their sole discretion, evaluate, investigate, determine and pay claims. The Trustees promulgate rules of procedure and fix a maximum amount of payment per claim payable on an aggregate amount, which may be paid because of the dishonest conduct of any one attorney. *See* C.R.C.P. 252.7.

The Colorado Supreme Court Office of Attorney Regulation serves as counsel to the Board of Trustees. Regulation Counsel receives and investigates all claims filed with the Fund. *See* C.R.C.P. 252.12.

IV. Eligible Claims

For a claim to be eligible for reimbursement, the loss must be caused by the dishonest conduct of the attorney. Additionally, the loss must arise out of and by reason of an attorney-client relationship or a court-appointed fiduciary relationship between the attorney and the claimant. *See* C.R.C.P. 252.10. Pursuant to court rule, the Trustees could not pay claims for losses incurred as a result of dishonest conduct committed prior to July 1, 1999. *See* C.R.C.P. 252.2(c).

On June 16, 1999, the Trustees adopted guidelines to carry out the purposes of the Fund. The guidelines set forth eligibility requirements, filing instructions, processing details and payment of award details. (Copies of the guidelines are available by contacting the Colorado Supreme Court Office of Attorney Regulation Counsel or by visiting our web site at www.coloradosupremecourt.com).

In cases of extreme hardship or special or unusual circumstances, the Trustees may, in their sole discretion, recognize a claim that would otherwise be excluded under the rules. *See* C.R.C.P. 252.10(e).

The Trustees require the Claimant to initiate a request for investigation with the Office of Attorney Regulation Counsel prior to consideration of any claim.

V. Claim Limits

At the inception of the Fund, the Trustees adopted a limit of \$5,000 as the maximum amount any claimant could receive from the fund regardless of the magnitude of the loss. Additionally, the Trustees initially adopted a maximum payment of \$20,000 in the aggregate regardless of the magnitude of losses any particular lawyer may have caused.

The Trustees subsequently set a \$50,000 per claim limit and a \$100,000 limit for losses caused by any one attorney. The amount of any award made is within the sole discretion of the Trustees.

During 2009, the Trustees met in subcommittees and debated several issues related to the financial well-being of the Fund. Over the course of several meeting the Trustees unanimously approved a recommendation made by one of the subcommittees. The Trustees adopted the following policy regarding claims previously approved but not wholly paid.

The Trustees shall reconsider all claims previously approved, but not wholly paid, at the final meeting of each calendar year, including the year the claim was initially approved and two successive years. (For example, assuming the claim was partially paid at the December 2009 meeting, then the committee shall reconsider the claim at the final meeting in 2010 and in 2011. As another example, if the claim was partially paid at the April 2009 meeting, then the Committee shall reconsider the claim at the final meetings in 2009, 2010, and 2011.)

VI. Claims - Reimbursements

As of December 31, 2007, the Trustees met on June 15, 2000; November 16, 2000; March 20, 2001; December 12, 2001; April 17, 2002; September 12, 2002; December 12, 2002; April 21, 2003; October 21, 2003; February 24, 2004; July 29, 2004; December 9, 2004; March 2, 2005; June 28, 2005; September 16, 2005; December 6, 2005; March 16, 2006; July 13, 2006; November 30, 2006; March 14, 2007; June 7, 2007; December 12, 2007; April 19, 2008; August 15, 2008; December 1, 2008; April 27, 2009; September 22, 2009 and December 3, 2009. A detailed chronology of claims and reimbursements follows in this report.

Total reimbursements as of December 31, 2009: \$3,800,261.96

VII. Restitution to the Fund

The Fund retained a Denver law firm to seek restitution to the Fund from every respondent against whom a claim is granted. The Fund also utilizes the services of the State Division of Finance Central Collections Division. The law firm works in

cooperation with the Attorney Regulation Counsel's Office to actively pursue restitution in every matter.
