**CERTIFICATION OF SALARIES
OF JUDGES OF COUNTY COURTS
IN CLASS C AND D COUNTIES**

To the General Assembly and the Controller of the State of Colorado:

Pursuant to §13-30-103(1)(k)(I), C.R.S., the State Court Administrator has determined and hereby certifies to annual salaries of judges of the county court in Class C and Class D counties and of all special associate, associate, and assistant county judges, for the fiscal year commencing July 1, 1984. This determination is based upon the following formula, established by the cited statute:

The following table sets forth the location, the average number of terminations for the three years ending December 31, 1983, in each location, and the salary, based upon the formula set forth above, to be paid to the judge in that location for the fiscal year commencing July 1, 1984.
