**CERTIFICATION OF SALARIES OF JUDGES OF COUNTY
 COURTS IN CLASS C AND D COUNTIES**

To the General Assembly and the Controller of the State of Colorado:

Pursuant to section 13-30-103 (1) (k) (I), 6A C.R.S., the State Court Administrator has determined and hereby certifies the annual salaries of judges of the county court in Class C and D counties and of all special associate, associate, and assistant county judges, for the fiscal year commencing July 1, 1992. This determination includes the increase in judges salary effective July 1, 1992, and is based upon the following formula, established by the cited statute:
