To ensure high quality attorney services the OCR uses a comprehensive evaluation strategy to ensure compliance with OCR practice standards and the Chief Justice Directive 04-06 (CJD) as it establishes attorney eligibility lists each year. Data in the charts below come from various components of this evaluation. The OCR created benchmarks to review each of these components to ensure consistency in application. The Stakeholder Report is generated for each attorney from an annual survey which is sent to Judicial Officers and various court staff, departments of Human Services staff, CASA agencies, probation officers and other involved attorneys. In FY19-20 the OCR received 1,844 survey responses concerning 247 attorneys; these included 361 responses from Judicial Officers.

In FY 19-20 OCR conducted 396 court observations involving 100 attorneys and 626 children/youth using standardized forms for D&N and JD cases and 252 reference interviews (with children/youth, parents, and caregivers) concerning the 86 attorneys under evaluation. The OCR will be assessing why the measure regarding attorney position was such a departure from pervious years.

The OCR maintains a robust training program in an inclusive learning and practice environment which provides ongoing and meaningful trainings tailored to the specialized needs of attorneys representing children. In addition, the OCR pairs new attorneys with seasoned mentors in the first year of their contract. In FY 19-20 there were 22 mentoring pairs covering 11 judicial districts. The OCR's training program ensures attorneys are current in legal developments, social science research, and best practices and is based on four core competencies that are the foundation of high-quality legal representation for D&N and juvenile delinquency cases. To ensure training is current and relevant 87 CLEs of outdated content was removed from the OCR's online training in FY19-20.
