## Office of Innovative Mobility

\$300,000- Innovative Mobility (formerly RoadX) - One of Governor Polis' first actions was to issue an Executive Order, "Supporting a Transition to Zero Emission Vehicles (ZEVs)". This Executive Order has a statewide goal of 940,000 electric vehicles on the road by 2030. The Executive Order tasked CDOT with developing a zero-emission vehicle and clean transportation plan. In an effort to ensure successful completion of the plan, the Office of Innovative Mobility is requesting \$300,000. This amount will provide funding for outside consultant support for stakeholder outreach, report preparation, and graphic design. The first draft of the report is scheduled to be complete by January 2020. Per PD 703.0, any use of Innovative Mobility funding requires Transportation Commission approval.

# Background on the Clean Transportation Plan

In January 2019, one of Governor Polis' first actions was to issue an Executive Order, "Supporting a Transition to Zero Emission Vehicles (ZEVs)," (Appendix A) which set a state-wide goal of 940,000 electric vehicles on the road by 2030. In addition, the Executive Order identifies CDOT's central role in promoting this vision, through active membership in the State's Transportation Electrification Workgroup, and tasking the Department with drafting a zero-emission vehicle and clean transportation plan.

In particular, the plan must "align transportation investments and programs with strategies that support widespread deployment of ZEVs and expand mobility options in ways that save energy, reduce congestion, and improve the safety of Colorado's transportation network. Given the intensive planning effort over the summer, CDOT intends to utilize as much data and feedback collected from that process, as well as from the Colorado Energy Office's update to the State's Electric Vehicle Plan, as possible. However, in order to ensure that this effort is thorough and data-driven, Staff requests a budget of \$300,000 to complete this effort, which may be more funding that necessary to complete the project, but allows for outside consultant support for stakeholder outreach, report preparation, modeling, and graphic design, if needed. A first phase of the report is slated to be released in January 2020, in conjunction with other related initiatives.

# Next Steps

Request Transportation Commission approval of \$300,000 for Clean Transportation Plan support.
