Enclosed is the approved Seventh Supplement to the FY 2011 Budget.

On December 1, 2010, Colorado Bridge Enterprise issued taxable Build America Bonds. The amount of Bond proceeds available for programming into Bridge Enterprise projects is \$298,143,596.

On December 20, 2010, the Legislative Council issued a new revenue forecast. The revised FY2011 FASTER Bridge Special Fund revenue estimate for Board's approval is \$68,900,000.

BONDING PROGRAM – Bridge Special Fund

- \$8,407,900 Debt service payment for Bridge Enterprise Bonds issued December 1, 2010.
- (\$150,000) No longer needed as rating agencies were paid from the Bond proceeds.
