Bridge Enterprise Q4 FY2019 Quarterly Report

Introduction

This report is the 33rd Quarterly Report (Report) published in support of the Colorado Bridge Enterprise (BE or "Program"). This Report outlines progress and accomplishments associated with the Program for work completed during April, May, and June of 2019; which coincides with the fourth quarter of CDOT's 2019 fiscal year (Q4 FY2019). Detailed information regarding the FASTER (Funding Advancement for Surface Transportation and Economic Recovery) legislation, program development activities, bond program, previous significant milestones and achievements can be found in the previous Program Annual Reports and Quarterly Reports viewable on the Colorado Department of Transportation (CDOT) website at www.coloradodot.info/programs/BridgeEnterprise.

The following is an itemization of significant Q4 FY2019 activities, some of which are discussed in further detail later in the report:

- Completed monthly updates to the overall Program Schedule for work completed in April, May, and June of 2019.
- Continued efforts to reduce excess budget on projects with completed phases and reallocated the budget

savings to other BE projects.

o Updated the BE Prioritization Plan based on the updated Staff Bridge Poor List (completed Q1 FY2020).

Program Highlights

Project Progress Update

In Q2 FY2019, BE Staff took a conservative approach to programming new projects due to significant program commitments associated with Proposition 109 and 110 projects. Resources that became available after the defeat of Prop. 109 and 110 in the November election were aggressively reprogrammed in Q3 and Q4 FY2019. During this quarter, BE funded the preconstruction phase for ten top tier structures from the July 2019 BE Prioritization Plan, itemized in *Table 1*.

BE Eligible Structure Population

As of the end of June 2018, there were a total of 217 structures considered eligible to receive FASTER funding. Due to refinements to BE eligibility criteria, the structure count increased to a total of 334 in July 2018. 21 structures were added to the program in FY2019 to increase the count to 355. The progress status associated with the 217 and 355 is itemized in *Table 2*.





Other relevant Q4 FY2019 bridge statistics are as follows:

- o Approximately 49% of FASTER eligible structures are now in construction or completed.
- o Approximately 9% of FASTER eligible structures are currently in design or design is completed.
- o Approximately 42% of FASTER eligible structures are remaining.

Program Activities and Accomplishments of Q4 FY2019

Program Schedule Update

The program schedule was updated three times during the period for work completed in April, May, and June of 2019. This includes publishing the monthly updated program bar-chart schedule, cost and schedule database, and list of projects with a Schedule Performance Index (SPI) less than 0.90. This information was consolidated and distributed to the Regional Transportation Directors (RTDs) and their respective Program Engineers. The SPIs reported for each month during the quarter are graphically depicted in *Figure C* below. The Active Project SPI provides a high-level snapshot of the actual performance vs the planned performance of projects in the BE program. The schedule represents the 36 FASTER eligible structures currently in the preconstruction and construction phases.




Figure C. Active Project SPI Reported by Month, for the Period

Ilex Project Update

In July 2015, construction began on the Ilex project which replaced bridges on I-25 between Ilex Street and City Center Drive in Pueblo. The Ilex interchange is the first segment to be constructed as part of the New Pueblo Freeway E.I.S. that was initiated in the early 2000's. Work included rehabilitation of bridges on northbound I-25 over US 50 Business Rt., I-25 over Indiana Ave., US 50 Business Rt. over the Arkansas River, Northern Ave. over I-25, and Mesa Ave. over I-25. The Ilex project was primarily funded by the BE program through FASTER Bridge fees, with the inclusion of R.A.M.P. funding.

Ten bridges in total were addressed by the project. Eight BE eligible structures, totaling over 130,000 sq. ft. in "poor" deck area, were addressed with BE funding. Two bridges were replaced, and six were rehabilitated, including the historic Green Truss Bridge on US 50 over Arkansas River (K-18-R). The project reached substantial completion in June 2019 and a ribbon cutting ceremony was held on June 27, 2019. Other project highlights include:

 Safety improvements included the widening of 3 bridges to current standards, straightening dangerous curves, adding acceleration/deceleration lanes, and resurfacing of surrounding streets

- Project contributed an estimated \$25M+ to the local economy
- Aesthetic and noise mitigation improvements of project corridor including a concrete wall panel cast with a baseball player
- Over 1 million tons of clean embankment imported to construct the project
- Much of the imported material replaced contaminated soil removed from the project

Central 70 Project Update

The FASTER Eligible portion of the Central 70 project includes approximately 8.5 miles of I-70 between Brighton Blvd. and I-270 in Denver. Six FASTER eligible structures will be addressed by the project, including "the Viaduct" (I-70 over US6, UPRR and CCD St.). These structures represent nearly 30% of BE's current statewide eligible bridge deck area. Additionally, "the Viaduct" was identified as one of the 30 worst bridges in the state when the Enterprise was created in 2009, and will be the last of the 30 worst bridges to be addressed.

In Q4 FY2019, BE staff continued coordination with the Central 70 project team to track project progress and refine BE program models as necessary. Additionally, the project completed several significant milestones which are summarized below.

April 2019

- 100% Denver Rock Island Railroad (DRIR) Bridge Plan approval on April 9, 2019
- Set bridge girders on the new southbound I-270 flyover to eastbound I-70
- Set bridge girders on the new I-70 over Peoria structure (bridge replacement)

May 2019

- 100% Burlington Northern Santa Fe Railway (BNSF) bridge plan submitted for approval
- Submittal of 95% Union Pacific Railroad (UPRR) bridge plans for review
- UPRR license agreements for infrastructure in their Right of Way (ROW) submitted for approval
- Placed bridge deck for I-70 over Peoria bridge (Phase 1)

June 2019

- UPRR acceptance of 95% UPRR bridge plans
- Submission of the 100% Cover Systems design
- Began construction on the Columbine and Clayton Street bridges, including closure of these streets for the 2019 Denver Public Schools (DPS) summer break (adjacent to
- Swansea Elementary School).
- Implemented the westbound Steele street off-ramp detour

Floyd Hill Project Update

This corridor improvement project includes the replacement of one eligible structure, F-15-BL, which carries traffic on westbound traffic on I-70 over Clear Creek and US 6 at the base of Floyd Hill. In Q2 FY2019, BE partially funded the eligible portion of the design and environmental phases for the Floyd Hill Project. Subsequently, the defeat of Propositions 109 and 110 in November 2019 created a significant funding "gap" for the Floyd Hill project.

In Q4 FY2019, BE sponsored a study to evaluate the stability of the existing bridge and identify the need for interim repairs. BE also continued collaboration with the project team to identify potential strategies to fund the project.

I-25 South Gap Project Update

In Q4 FY2019, BE funded the construction phase for two eligible structures being addressed by the I-25 South Gap project, the I-25 bridges over Upper Lake Gulch Road (H-17-CH/CI). It is also anticipated that a third FASTER eligible structures, County Rd 404 over I-25 (H-17-CF), will be funded in Q1 FY2020. The decks of H-17-CH/CI/CF are in "poor" condition, and several of the substructure units supporting the bridges are in state of advanced deterioration. Additionally, all three structures have substandard geometry.

BE anticipates that the cost to replace H-17-CH/CI/CF will be reduced due to the economy of scale of the I-25 South Gap Project as compared to a standalone project. H-17-CH/CI are currently at 90% design, and are scheduled to be delivered with Package #3 of the project. H-17-CF is currently in conceptual design, and is scheduled to be delivered with Package #4 of the project.

Speer Blvd and 23rd Ave over I-25

In Q3 FY2019, BE funded the eligible portion of the preliminary design and investigation for the Speer Blvd and 23rd Ave over I-25 bridge replacement project. This project includes the replacement of three eligible structures (E-16-EW/EO and F-16-DA), reconstruction and reconfiguration of the interchanges at Speer Blvd and 23rd Ave.

The project will eliminate existing substandard vertical clearance conditions, mitigating damage caused by high-frequency truck strikes and opening the corridor to unrestricted freight traffic. Additionally, the planned replacement structure will accommodate future corridor modifications of I-25 in through Central Denver. The ongoing I-25 Central Planning and Environmental Linkages (PEL) study, is evaluating various alternatives to improve local and regional mobility through the corridor segment.

In Q4 FY2019, BE tracked the status of the PEL study and upcoming Request for Proposal, and evaluated programmatic impacts based on anticipated project timing and cost.

Prioritization Plan

Bridge Enterprise staff completed the semi-annual update of the Prioritization Plan² in July 2019 based on the updated "poor" bridge list released by CDOT Staff Bridge. This information was advanced to the Q4 FY2019 report for expedited distribution. Pursuant to this update, four structures were added and can be found in *Table 3*. In accordance with PD BE16.1, BE staff performed a programmatic analysis of all statewide BE eligible structures that have not been replaced or rehabilitated based on BE guidelines. This included extensive coordination with CDOT Region staff and Staff Bridge Branch.

Four-Year Program Plan

In Q4 FY2019, Bridge Enterprise staff finalized the program's Four-Year Capital Project Plan which incorporates current program commitments, the BE Prioritization Plan, forecasted revenues, Department/FHWA policy or guidance, Board resolutions, etc. The BE Four-Year Capital Project Plan includes a summary of the FY2019 program and an update on active BE projects, program fiscal information, the program forecast for FY2020-FY2023, and a summary of program performance.

Budget and Encumbrance Balances

Bridge Enterprise staff continues to coordinate with the Region staff to de-budget projects that are substantially complete in accordance with the SB 16-122. *Table 5* shows the encumbrance and budget balances as of June 30, 2019, by Region, for projects that have been substantially complete for more than six months.

Since March 31, 2019 the budget and encumbrance balances have increased by \$2,019,612. During this time, three projects were added and zero projects were removed from the list leaving three projects that are six months or older since substantial completion. Financial Information

The following is a program overview of financial statistics as of June 30, 2019.

- The program has multiple funding sources including: proceeds from the Build America Bond program, FASTER bridge dollars which is commonly referred to as the statewide pay-go program (collected yearly revenues from vehicle registrations), Bank of America Loan, and Other Funds which are primarily Federal-aid BR funding.
- From program inception (life-to-date) through June 30, 2019, a total of \$1,338.5M has been budgeted (all funding sources), and Expenditures and Encumbrances are \$990.0M and \$68.7M (all funding sources), respectively. Reference *Table 6* below for details by funding source.
- For comparison purposes, the totals from the previous quarterly report (Q3 FY2019) are also reported in the far-right column.
- All \$307.9M of bond proceeds and interest earnings available have been expended as of June 30, 2016.

The Statewide Bridge Enterprise program currently consists of 161 funding-eligible structures; including 89 structures budgeted with bond funds. The structure count has increased due to the addition of several new structures that have advanced to preconstruction this spring. The current programmed amount for these 161 structures is approximately \$1,478.6M. *Table 7* below provides an itemization of current funding sources for the Bridge Enterprise program.

The Program Allocation Plan³ tracks BE projects programmed since the beginning of the Bond Program by funding source, preconstruction activity and construction activity. In addition, the Program Allocation Plan includes projects that have yet to be budgeted, primarily FY2020, and includes budget adjustments that have not been posted to the accounting system as of June 30, 2019. Projects that were budgeted prior to the Bond Program are shown in summary at the bottom of the third page as Pre-Bond Projects. The program life-to-date (LTD) total liabilities for the BE program are \$1,478.6M, a decrease of \$8.6M from the \$1,487.2M total liability reported on March 31, 2019. This is primarily the result of budget releases and revised estimates. This amount also includes the design budget for I-25 over South Academy (I-17-GQ/GR) in El Paso County; the BE portion of the Military Access, Mobility, and Safety Improvements project submitted for the Better Utilizing Investments to Leverage Development (BUILD) grant program.



The Four-Year Quarterly Cash Flow Projection (*Figure D*) depicts all current available BE cash balances, forecast revenues, and forecast expenditures for currently programmed projects. BE liabilities and the timing of milestone payments for the Central 70 have been modified by the Second Amendment to the IGA between CDOT, HPTE and BE. These changes have been incorporated in the cash flow. This forecast model also considers Resolution BE 15-8-2 which sets parameters for the use of BE funds during the construction period of the Central 70 project. In addition, the forecast contains the Capital Performance Payment (Availability) which grows at 2% per year.

Bridge Enterprise has forecast the cash balance to decrease by \$223.9M, mostly due to the Central 70 project during the period of the Four-Year Cash Flow (July 2019 through June 2023), down to \$25.0M. The low point in cash is forecast at \$11.7M at March 2023 and then begins climbing back up to \$25.0M, the established cash floor for BE. In accordance with the Second Amendment to the IAA, the final milestone and substantial completion payments are now both scheduled in September of 2022. In accordance with Resolution BE-17-11-1, the contingency for the BE share of potential supervening events has been included in the cash drawdown forecast.

BE will continue to monitor and update the model and incorporate the most current revenue, cash and drawdown forecasts.

Figure D. Four Year Quarterly Cash Flow Projection



As of Q4 FY2019, actual YTD FASTER revenues were \$105.7M, which is \$2.3M below the FY2019 revenue forecast of \$108M. This is \$0.3M below the \$106.0M collected in FY2018. Once new revenue estimates are developed by the OFMB, BE will incorporate the revenue estimates into the budget and cash flow forecasts. This information is shown below in *Figure E*.


Figure E. Forecast vs Actual FASTER Revenue Comparison

The Total Program Financial Performance graph (*Figure F*) depicts actual expenditures and encumbrances against projected expenditures, inception to date (ITD). Projected expenditures are forecast at \$1,000M on June 30, 2019, an increase of \$14M since March 31, 2019. Actual LTD expenditures as of June 30, 2019 are \$990M as compared to \$969M on March 31, 2019, an increase of \$21M or 2.1%. The current encumbrance balance is \$69M compared to \$42M on March 31, 2019, an increase of \$27M or 64%.
