

### THE DEAN OF THE COLLEGE OF EDUCATION

During the 2008-2009 Academic Year, in keeping with strategic planning best practices, the College of Education (COE) faculty and staff revised the COE vision and mission statements as well as the goals. Our new vision statement is: "The College of Education is a premier learning community of teachers, leaders, and counselors who contribute positively to a global society." In addition, the new mission statement emphasizes the preparation of skilled professionals who "inspire excellence and create transformative change in the schools and communities in which they serve."

The premier accomplishment is that the Department of Counseling and Human Services was re-accredited by the Council for the Accreditation of Counseling and Related Educational Programs (CACREP). It is salient to note that all 245 standards were met. This accreditation decision indicates that the unit and its programs meet rigorous standards set forth by the professional education community.

The COE faculty and staff modeled the ideals of the mission statement to "promote and model innovative, ethical, and research-based practices," when they were awarded more than \$500,000 in sponsored research grants to improve the recruitment and training of southern Colorado K-12 teachers. The total of these grants is approximately 50 percent of the state funding dispersed by the Colorado Department of Higher Education for teacher preparation. This demonstrates the high quality of the COE faculty and staff.

I thank faculty, staff, and students for their contributions to our successful year.



## Diversified Revenue




External grant funding is one measure of scholarly activity in the College of Education. Research grants provide an opportunity for faculty and students to engage in collaborative studies with educators and students in PK-12 settings as well as other researchers in institutions across the nation. Training grants provide scholarship money to students interested in becoming teachers. The major grants that the College received in 2008-2009 reflect both research and training opportunities. As the bar graphs in the table illustrate, the success of the College of Education in securing external grants has shown a steady increase over the past ten years.



# DIVERSIFIED FUNDS

The College of Education has undertaken several entrepreneurial activities this year that do not fall within the parameters of Extended Studies or regular course offerings. These include our Daegu English Village partnership with Yeungjin College of South Korea, as well as customized professional development programs for school districts in which COE provided specialized training in Culturally Responsive Teaching, Leadership, and Counseling.



# EXTENDED STUDIES

With the annual Culturally Responsive Teaching, Leadership and Counseling Symposium, as the anchor, COE laid plans to expand its Community Learning Series into a comprehensive program that will offer symposia, lectures, seminars, and specialized classes for community members of all ages. It will include youth programs, ESL training, personal interest seminars, programs for military, as well as special presentations on diversity and multicultural education.

#### **College of Education Extended Studies New Programs 2008-2009**

#### Teaching English as a Second/Foreign Language (TESL/TEFL Certificate Program)

This dynamic TESL/TEFL program is specifically designed for both domestic teachers and international teachers. Each has its own certification process. The 12-credit program is offered in three convenient formats: completely online, on the beautiful UCCS campus in Colorado or in a customized hybrid program tailored for specific groups, with summer courses on campus and online courses in fall and spring. The TEFL Certificate consists of four graduate courses, 12 semester hours.

#### Partnership with Future Horizons

This partnership is to offer credit for Autism Spectrum Training around the country.

#### <u>eEducators</u>

This partnership program is to offer UCCS credit for the online professional development courses eEducators offers. The *eEducators* online courses program are committed to providing quality continuing education courses dedicated to educating today's teachers.

#### National Association for Multicultural Education (NAME) Conference

The Founders of NAME envisioned an organization that would bring together individuals and groups with an interest in multicultural education from all levels of education, different academic disciplines and from diverse educational institutions and occupations. The College of Education has partnered with the NAME conference to offer attendees UCCS credit 2-3 credit hours for attendance and completion of assignments.

#### Specific Learning Disabilities with the Colorado Department of Education

The College of Education Extended Studies office will be working with the Colorado Department of Education to offer credit for specific learning disabilities online training which focuses on the changing legislature and criteria for special education programs.

## OFFICE OF GLOBAL EDUCATION



The College of Education (COE) is the first college on the UCCS campus to establish an Office of Global Education (OGE) under the COE Office of Extended Studies.

Dr. Kyla Hammond, Executive Director of Enrollment Management and Extended Studies, officially established the office in July, 2009. Anthony Shull, former Director, Department of Languages at the Tec de Monterrey in Mexico City, has been named as the Director of Global Education. He will be assisted by Debby Jennings as the Program Liaison.

Given that the establishment of global programs supports the strategic plan of the UCCS campus, the mission of the COE Office of Global Education is to develop educational programs and partnerships that: 1) cultivate and develop a global learning environment for the 21st century, and 2) establish an environment which provides experiential English education for global citizens.

Drawing upon our experience in partnering with Yeungjin College of South Korea to open the Daegu English Village, COE plans to add several new international programs within the next three years including:

- Setting up partnerships with other world universities;
- Developing Hybrid English as a Second/Foreign Language Programs for domestic and international teachers;
- Offering international study tours for cultural competency;
- Increasing C1 enrollment by attracting American students wanting international opportunities and by increasing international student enrollment at UCCS; and
- Establishing academic programs that will offer international research, exchange or scholarship programs for students, faculty and staff.



### Strategic Enrollment Managment





# COE ENROLLMENT

The College of Education has been very successful in increasing enrollment and growing our academic programs and has reflected an overall increase of plus 9.6 % over the previous year. While maintaining our high admissions standards and ensuring quality in our programs, we undertook a number of recruiting, marketing, and customer service initiatives designed to meet the needs of our student population. 



### CAMPUS PROGRAM STUDENT INQUIRES



### Academic Programs



#### **Department of Counseling and Human Services**

#### **Department Updates:**

The Department of Counseling and Human Services (DCHS) prepares professional counselors who are fully qualified to work in school, mental health agencies, private practice, career guidance, the military, business and industry and other education and counseling organizations. Two specialization tracks are available for students pursuing the Master of Arts degree in Counseling and Human Services: school counseling and community counseling. Both tracks are nationally accredited by the Council for the Accreditation of Counseling and Related Educational Programs (CACREP).

#### **Program Development:**

1. In the last year DCHS articulated and fully implemented three overarching goals (candidate learning objectives or CLOs) for graduates of the Masters degree program.

CLO 1. Graduates of the Counseling and Human Services program will have a mastery of the body of professional knowledge that comprises the profession of counseling and that is necessary to ethically serve those seeking counseling services.

CLO 2. Graduates of the Counseling and Human Services program will have a mastery of the specific counseling skills and techniques necessary to serve as an ethical and effective professional counselor.

CLO 3. Graduates of the Counseling and Human Services program will have examined their own personalities and motives for becoming counselors and have gained self-awareness of their personality style, their strengths and limitations, and have developed the adaptability necessary to maximize their strengths and overcome their weaknesses in their work with clients.



2. The DCHS program was re-accredited by CACREP until 2016. All 245 standards reviewed were met; no rejoinders were required.

Particular strengths of the DCHS Masters program noted by the CACREP team that visited March 1-4, 2009 were:

- Professional service is supported with faculty reporting quality activity at state and national conferences.
- The self-awareness component of the program was highly praised.
- Current and former students, and site supervisors were complimentary of present faculty, in demonstrating a high level of professionalism, being supportive and approachable, and providing current and innovative vision.
- All stakeholders complimented the cohort model.
- 1. Passing the national, standardized Counselor Preparation Comprehensive Examination (CPCE) is required for graduation from the DCHS program. In March, 2009, 41/42 students passed the CPCE; 1/3 scored in the top 10% in the nation; 5 students (12%) scored in the top 2% in the nation.
- 2. DCHS exceeded its enrollment goal by 22%. 53 qualified applicants were accepted into the first year of the program 28 into the night cohort and 25 into the day cohort.
- 3. All courses in the DCHS were reviewed in the process of CACREP accreditation, and curriculum was updated and improved to better meet the needs of current students and to better prepare graduates to meet the needs of their future clientele in a changing world. An online component was added to every course. Each student will now prepare an electronic portfolio comprising work completed during the program, in multiple media.
- 4. The Counseling and Human Services Masters degree program is being expanded incrementally to 60 credit hours, to meet revised CACREP standards and licensing requirements. A lab in Family Counseling was added in Spring 2009 to raise the number of credits required for graduation to 51. A 3-hour course in Crisis and Trauma Counseling is currently being developed and will be piloted in summer 2010. Students entering in June, 2010 will complete a 54-hour program.
- 5. The DCHS continues to prepare Air Officers Commanding to effectively serve USAFA cadets with excellent counseling skills. The AOC program was commended by leadership at USAFA, of the U.S. Air Force, and of other military academies. \$342,200 was collected from USAFA in the last fiscal year, equaling 28% of total College of Education Extended Studies revenues.
- 6. Faculty members of the DCHS have established partnerships both in and outside of the College of Education. For example, Drs. Williams, Wehrman and Martinez (LRF) premiered an annual all-day workshop, to be held in November, for school counselors and administrators to learn to understand each other's roles and collaborate.



#### **New Faculty**

After a nationwide search and on-campus visits of three highly qualified counselor educators, Dr. Julaine Field joined the DCHS faculty as a tenured Associate Professor in August, 2009. Dr. Field has been a counselor educator for seven years, has worked in both school and clinical mental health settings, and has authored publications related to counselor advocacy, gender identity, and relational and social aggression.

Dr. Julaine Field, Associate Professor, gracefully made the transition from Slippery Rock University in Pennsylvania to UCCS, coming in with tenure, and currently teaches Group Counseling. Her publications and presentations within the last year have been focused primarily on girl bullying/relational aggression, including co-authoring a book on that subject published by Corwin Press, developing a measure of relational aggression which she published in the *Journal of Psychoeducational Assessment*, and presenting at the American Counseling Association annual conference in Charlotte in March. Dr. Field left positions in Pennsylvania on the Transforming School Counseling Advisory Committee and at her former university as president of the Phi Kappa Phi Honor Society, Chair of the President's Commission for the Status of Women, and advisor for the Feminist Majority Leadership Alliance. Since arriving at UCCS, she has assumed leadership of the College of Education's Innovations and Research Committee, has had a proposal accepted for presentation at the ACA conference in March, 2010, and started planning to bring the D.R.E.A.M Girls residential, leadership camp for 7<sup>th</sup> and 8<sup>th</sup> grade girls from Western Pennsylvania that she co-directed to Colorado, in partnership with Smart Girl.

#### **Faculty Accomplishments:**

Dr. David Fenell, Professor and Chair, a recently retired Army Behavioral Sciences Officer continues his work in identifying and educating counselors about the culture, counseling needs, and treatment of military combat veterans and their families. Recent national presentations have included the keynote address for the Association of Counselors in Education and Government, as well as presentations for the American Association for

Marriage and Family Therapy and the Association for Counselor Education and Supervision (ACES). Dr. Fenell co-authored two book chapters (in press) on counseling children of deployed warriors, articles on work and conflict in military families and on the impact on families of frequent deployments, and is completing a revision of his

textbook, *Counseling Families: An Introduction to Marriage and Family Therapy*. Dr. Fenell has also been tapped as a resource for other department chairs, most recently speaking at the ACES conference about finances and budget.

Dr. Rhonda Williams, Assistant Professor and Coordinator of the School Counseling program, was selected as the 2008 post-secondary counselor educator of the year by the Colorado School Counselors Association. The Smart Girl program for middle school girls, for which she is Program Director, continues to be a focus of her research, writing and presentation, including a full-day pre-conference workshop at the annual American School Counselor Association conference in Dallas, TX in June and two leadership trainings in Colorado. Also interested in diversity and social justice, collaboration between school counselors and administrators, and service learning, Dr.





Williams has collaborated with other UCCS faculty on articles published in the *Journal of Race, Gender, Class* and the *Academic Exchange Quarterly*, on a book chapter regarding the school counselor's role in supporting children of military families, as well as writing a bi-monthly column for *ASCA School Counselor* as Ethics Chair for the American School Counselor Association. Dr. Williams serves as Executive Director of the Colorado School Counselor Association, on the Colorado Core Counselor Grant Advisory Committee, on the UCCS Diversity Committee, and chairs the College of Education Diversity Committee.

Dr. Joseph Wehrman, Assistant Professor and Coordinator of the Community Counseling, soon to be Clinical Mental Health Counseling, program was appointed to a three-year term as a board member for the National Board for Certified Counselors, effective July 1, 2009. This highly sought-after position provides him direct influence on the profession; 42,000 counseling professionals hold national or international NBCC certification. Dr. Wehrman also serves on the Association for Play Therapy's national Ethics and Practice Taskforce, which is charged with revising the code of ethics for registered play therapists, the UCCS Student Achievement and Assessment Committee, and the Assessment Committee of the College of Education. Within the last year he obtained a license as a professional counselor in Colorado and the Approved Clinical Supervisor credential, and was given the College of Education's Technology Award. Dr. Wehrman has given presentations on a range of topics: on translating group process into children's language and on educating counselor trainees regarding military culture at the 10/2009 Association for Counselor Education and Supervision conference, on providing culturally responsive counseling following war, natural disaster and crisis at both the Association for Mental Health Counselors national conference and the CRTLC symposium at UCCS, and on play therapy at the Colorado School Counselor Association conference. He has co-authored, with colleagues in the College of Education, articles on collaboration between counselors and education administrators, on using clickers in education, and on deployment and post-deployment counseling.

Dr. Catharine Beecher, Senior Instructor, facilitated the DCHS's successful faculty search, coordinated and administered the CPCE and the National Counselor Examination (NCE), and completed several written reports regarding the activities of the DCHS. As faculty advisor to the UCCS chapter of the Chi Sigma Iota International Counseling Honor Society, she oversaw the DCHS annual Supervisors Workshop, graduation ceremonies, NCE study and review workshop, CSI induction, and attended leadership training at the American Counseling Association annual conference, where she also obtained a credential in supervision. Within the last few months, Dr. Beecher received her license as a professional counselor in Colorado and the Master Practitioner credential for Myers-Briggs Type Indicator administration and interpretation. Dr. Beecher serves on the COE Conceptual Framework Committee.

Ms. Mari McGuinness, who is ABD at the University of Northern Colorado in Greeley, was hired as a full-time instructor, where she continues to make research methods understandable to counseling students. She instructs across the DCHS curriculum, including teaching Human Growth and Development to the students in the USAFA Air Officers Commanding cohort, and supervises field experience classes for both clinical mental health and school counseling students. Mari is overseeing the purchase and installation of technology into the DCHS labs that will enable all students to record and review their counseling skills.



#### **Department Updates:**

The Department of Curriculum and Instruction faculty have had a productive and challenging year while developing new programs and enhancing current offerings. Our goal is to prepare skilled professionals who inspire excellence and create transformative change in the schools and communities in which they serve. We actualize this by enhancing scholarship, achievement, and service through collaborative partnerships, promoting and modeling innovative, ethical, and research-based practices and, embracing inclusion and social justice. In supporting this mission, we strive to:

- Two tenured or tenure-track faculty searches are in progress, Fall Semester, 2009.
- Two new part-time instructors were hired Fall 2009 Nancy Latka (Site Professor at Vista Ridge D49 and Secondary Social Studies Methods Instructor) and Kristie Ewig (Site Professor at Wasson D11 and Secondary English Methods Instructor).
- The Galileo Middle School D11 project continues through 2011 with professional development on culturally competent assessment, differentiation, planning, and teacher leadership.
- The **Pikes Peak STEM Compact** (PPSC) project ended in the summer of 2009 with UCCS assuming the role of UCCS STEM Center for the southern Colorado region. The creation of the UCCS STEM Center, in collaboration with community partners in the Pikes Peak region, included the development of a comprehensive webpage.
- Ongoing improvement and update of the C & I webpage continues to reflect program development and department changes.

#### **Program Development:**

- **Dr. Barbara Frye, Director, Teacher Education & Licensure Programs** has developed three new secondary PDS sites (Galileo D11, Wasson D11, and Vista Ridge D49) and one new elementary PDS site (Odyssey D49).
- Dr. Barbara Frye, Director, Teacher Education & Licensure Programs has continued to expand the Alternative Licensure Program with the addition of online classes. The online delivery occurred in Fall, 2009.
- **CURR 5000** Foundations: History and Research in Curriculum course has been redesigned and will be offered Spring Semester, 2010.
- MS in the Sciences (MSc) is being offered as a new program as of September, 2009.
- Gifted and Talented endorsement will be re-written and re-submitted in November, 2009.
- Interdisciplinary Studies Degree is in progress.
- **Early Childhood Degree and Endorsement** is in progress.

#### **Faculty Accomplishments:**

- **Dr. Clint Fisher** gave an invited presentation at the National Education Computing conference (part of the annual meeting of the International Society for Technology in Education) in Washington, DC, in July, 2009.
- **Dr. Barbara Frye** attended the Association of Colleges for Teacher Education AACTE Leadership Academy for Chairs and Deans in June, 2009.
- **Dr. Barbara Frye and Dr. Catherine Kelly** have offered ongoing professional development at Galileo Middle School in Culturally Responsive Teaching, strategic planning, differentiation, language arts, coaching in the content areas, technology, teacher leadership, and development of a PDS site.
- Dr. Barbara Frye, Dr. Catherine Kelly, Dr. Leslie Grant, and Dr. LaVonne Neal presented on Culturally Responsive Teaching at the UCCS Building Inclusiveness Conference in May, 2009.
- **Dr. Leslie Grant** has an ongoing cohort of LDE students in D2 and will begin an additional cohort in D11 in January, 2010.
- **Dr. Leslie Grant** has written and submitted a Professional Development Grant for Linguistically Diverse to the Institute of Education Sciences. It is entitled *Enhancing the Instruction of English Language Learners: Professional Development of Educators in the Pikes Peak Region.*
- Dr. Leslie Grant, Dr. Linda Button, Ms. Cindy Brown, and Ms. Yvonne Bogard presented on technology in teacher education at the Colorado Learning and Teaching with Technology in Boulder, CO in August, 2009.
- **Dr. Leslie Grant and Ms. Yvonne Bogard** will be presenting a paper at Colorado TESOL on using vodcasting in teacher training.
- **Dr. Leslie Grant and Dr. Catherine Kelly** offered language and mathematics and science content presentations for 250 early childhood specialists in the Aurora Public Schools, Aurora Colorado in September, 2009.
- Drs. Catherine Kelly, Barbara Frye, and Leslie Grant presented a paper on teacher change and mentorship at the annual Northern Rocky Mountain Research Association meeting in Jackson Hole, WY in October, 2009.
- **Dr. Catherine Kelly** presented a paper on teacher leadership and mentoring in mathematics and science at the annual School Science and Mathematics Association meeting in Reno, NV in October, 2009.
- **Dr. Catherine Kelly** was nominated for and elected for a three-year term as a Board Member and Director-At-Large of the School Science and Mathematics Association.
- Dr. Mark Malone, has developed the MS in the Sciences (MSc) and began course offerings in September, 2009.
- Ms. Nancy Reif, Dr. Linda Button, Dr. Greg Button, and Dr. Leslie Grant presented at the NAME conference in Denver this October, 2009.
- **Dr. Barbara Swaby**, was the UCCS Convocation Faculty Keynote speaker at the Fall Convocation ceremonies in August, 2009.

## LEADERSHIP, RESEARCH, AND FOUNDATIONS

#### **Department Updates:**

The Ph.D. Leadership, Research and Policy program began its third year in the Fall/2009 with twenty-five students. The Master's in Student Affairs in Higher Education began its second cohort in the Fall/2009. Colorado Springs District 11 began a new cohort in the Master's in Leadership Education program in the Summer/2009.

#### **Program Development:**

In the Fall/2009, the Leadership, Research and Foundations department developed a new course (LEAD 517 Culturally Responsive Leadership) to be incorporated into the new Culturally Responsive Teaching, Leading and Counseling (CRTLC) Certificate program. This course has been presented in several districts within the Colorado Springs and Denver area.

LEAD 561: Social and Cultural Foundations of Higher Education was developed for the Master's in Student Affairs in Higher Education program.

#### **Department Updates:**

The Department of Special Education offers undergraduate and graduate courses that lead to initial licensure as a Special Education Generalist; online and traditional courses that allow already licensed teachers to receive an "added endorsement" as a Colorado Special Education Generalist; and online or traditional coursework that leads to the MA in Special Education. The department continues to expand its district-level programs by offering added endorsement options to cohorts of general education teachers in Districts 2 and 11. For District 2, this is the third year we have offered such programming. The Department of Special Education's enrollment was 107% of our fall 2008 enrollment. This increase represents the hard work and dedicated efforts of our faculty and staff.

Faculty continue to be actively engaged in meaningful scholarship and service by publishing in peer-reviewed journals and other outlets and presenting at state, national, and international conferences. Faculty service includes appointments to state, national, and international boards and committees. The department has also been working diligently in anticipation of our upcoming accreditation visit by CDE and CDHE. All programs offered by the department are linked to state and national standards as documented in our Institutional Report and Content Area Report submitted earlier this semester. The department continues to seek guidance from our K-12 partners by convening our Special Education Advisory Committee meeting each semester to receive feedback on programming and teacher preparation options, as well as future directions.

#### **Program Development:**

A new course has been added to our current program offering titled Disabilities Studies in Education (DSE). This course created by Dr. Kasa-Hendrickson replaces the Professional Seminar course which has been offered for a number of years. The DSE course is required for all undergraduate and graduate students and will also be one of the courses offered as part of the College of Education CRTLC Certificate. The department has also instituted an e-mail communication system (E-mail Blasts) where departmental updates, announcements, and opportunities are sent directly to all students.

#### **New Faculty:**

The department welcomed Drs. Janet Sauer and Elaine Cheesman who joined our faculty staring this fall. These talented individuals were selected from a pool of national and international scholars who applied last year. Dr. Sauer teaches our Introduction to Special Education and the Current Topics courses and Dr. Cheesman teaches the Multisensory Structured Language Education and Differentiated Instruction courses.



#### **Faculty Accomplishments:**

Below are just a few of the accomplishments that faculty have accrued over the past year.

Dr. Lindy Crawford was awarded two grants, including a 1.5 million dollar grant from the U.S. Department of Education that will investigate strategies for assisting middle school students with math learning disabilities and a \$70,000 Teach Colorado Grant that will support students who have a background in Math, Science, or Engineering who are interested in becoming a teacher.

Dr. Randall De Pry is a co-principal investigator on a \$240,607 grant from that will assist para-professionals in becoming licensed math, science or special education teachers. He is also presenting a paper on student participation in the functional assessment and behavior intervention planning process at the International Association for Positive Behavior Support conference in St. Louis this March.

Dr. Kasa-Hendrickson and Cheesman recently had papers published in the Journal of Developmental Processes and Teacher Education and Special Education respectively. Dr. Kasa-Hendrickson also served as co-author for a booklet published by Peak Parent Center titled Fast Flip Booklet: Supporting Paraprofessionals: Tips for teachers, parents, and paraprofessionals.

Dr. Sauer has submitted four presentation proposals to national or international conferences, including three to the prestigious American Educational Research Association (AERA).

Dr. La Vonne Neal was selected as a keynote speaker at the National Association for Multicultural Education (NAME)conference to be held in Denver in October.

Dr. Olvey continues to offer leadership to the Colorado Department of Education on Response to Intervention (RtI) and as a member of the Board of Directors (Vice President) for Peak Parent Center in Colorado Springs

Laura Marshall continues her scholarship in the area of self-determination including presenting at the State Council for Exceptional Children Conference--Courage to Risk on Involving Elementary Students in their Education and Planning.






#### C2 Program Interest, January 2009 to October 2009: Number of inquiries 251

Included were photographs of rare documents highlighting the most important communications between the national Office and the Topeka Branch of the NAACP, together with other documents rarely seen related to the Topeka desegregation case. The presentation concluded with questions and answers from one who witnessed many of the meetings and met many of the national representatives of the NAACP.






# GRAD ALUMNI SURVEY OVERVIEW

#### Graduate Alumni Survey overview

The University of Colorado at Colorado Springs annually distributes a graduate alumni survey. The survey contains generic questions asked of all graduate of UCCS. Departments in the College of Education have added additional, more specific questions to his survey. The office of Institutional research at UCCS analyzes responses and provides data. We share results from only two questions. Results for these two questions are disaggregated by department and reflect changes in student responses over the past five years. Graduates across all four departments reported overwhelmingly that their degrees enabled them to get the position they wanted. Graduates also agreed that they would recommend their COE degree program to interested individuals.










Graduates of our education and counseling programs are strong academics, skilled practitioners, consummate professionals, and culturally responsive. We value these traits and measure them through an employer.

In the winter of 2007 the College of Education designed and distributed a web-based survey to employers of recent COE graduates. Questions were grouped into four primary categories:


- (1) Dispositions

- (4) Technology Skills




#### College of Education Alternative Licensure Program Employer Survey




## College of Education Counseling Survey
