It highlights some of our Center's most remarkable educational programs, community outreach events, research activities, and clinical ethics initiatives, and it is a celebration of the people and programs that are rapidly making the University of Colorado a national example of excellence in bioethics and health humanities.

After you peruse this report, please stop by the office to say thanks to our dedicated staff. None of these remarkable accomplishments would have happened without the diligent efforts of Songyuan Gu, Meleah Himber, Rosa Lawrence, Julie Ressalam, MaryLou Wallace and David Weil.

Of course the report also reflects the extraordinary talents and energy of our Center faculty. Through our ongoing strategic planning process, our faculty and staff come together each year to develop a set of clear and shared goals and to implement plans and programs to help us reach them. The fruits of these shared efforts are highlighted in this report.

As just a few examples, the spring of 2018 brought Dr. Eric Campbell to our Center as Director of Research (see page 16) – and he immediately started increasing our research portfolio by receiving an R01 grant within weeks of his arrival! By the end of 2018, our Graduate Certificate in Health Humanities and Ethics had grown at an astonishing rate in its first 18 months with more than 30 students enrolled. (see pages 14-15). Meanwhile on our clinical service, 5 of our ethics consultants at UC Hospital and Children's Hospital were certified in the first year of professional certification by the HCEC Certification Commission (see pages 6-7). Under the category of service to the community, our *Capturing Grace* dance program drew our largest audience ever for a community event (see page 9). Our annual Holocaust Genocide and Contemporary Bioethics Program expanded again by forming a strong partnership with the US Holocaust Memorial Museum in Washington DC (see page 11); and the Aspen Ethical Leadership Program celebrated its third year of continuous growth (see page 15).



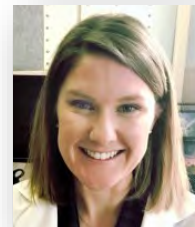
Academic Leadership Council

Healthcare Ethics Consultant-Certified Program

Be a leader in the evolution of healthcare ethics consulting

Clinical Consultation Services



Ethics Programs are expanding their reach to help clinicians at the bedside



CHCO - the Ethics Liaison program continues to thrive and grow with 63 liaisons (2 child life professionals, 2 clinical social workers, 1 research coordinator, 1 chaplain, 2 physicians, 3 patient advocates, 1 clinical educator, 1 respiratory therapist, 1 clinical research librarian and the rest are nurses). There are increasing numbers of moral distress rounds with a total of 2-3 each month.

A new "Ethics Ambassador," program is kicking off at **UCH**. Seven new Ambassadors will be working with their units/departments to bring ethics education to the bedside. The new Ambassadors include 3 nurses, 1 physical therapist, 1 social worker, 1 research assistant and 1 resident physician. This program is modeled after Children's Hospital Colorado's innovative Ethics Liaisons Program, which currently has 63 professionals working throughout the organization.

Consultation Teams at UCH and CHCO work on Quality Improvement Projects



Teams have held training sessions on ethics consultation (CHCO and UCH), engaged in strategic planning (CHCO), developed tools for the monthly review of ethics consultation notes (CHCO), and continued building a REDCap database for ethics consultations (UCH and CHCO) to provide data for QI reporting and outcomes research.

Community Outreach: Speakers Bureau

In 2018 we expanded our Speakers Bureau with an emphasis on addressing community-oriented talks.

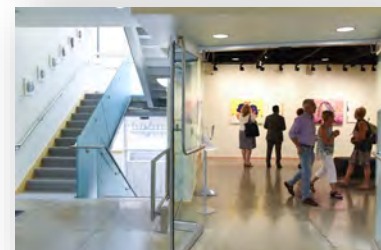

Education and Training

Center faculty engage with learners across all professional schools and all campuses and major hospitals in the University of Colorado system. Our Certificate Program in Health Humanities and Ethics, launched in 2017, is growing with 33 students and two new courses this year.

Research

The Center is investing in our strategic pillar to carry out leading-edge empirical research in bioethics and health humanities. We have an active and growing research portfolio, reflecting collaborations across the campus, state and nation.

Highlights:

- Eric Campbell, PhD, Director of Research, hits the ground running, embarking on a NIH-RO1 funded study to survey physician attitudes and perceptions of patients with disabilities.
- Matthew DeCamp, MD, PhD was recruited from Johns Hopkins, as Associate Professor.
- A faculty recruitment search, lead by Marilyn Coors, PhD, reviewed 43 applicants, conducted 11 videoconference screenings and invited 4 candidates to campus for interdisciplinary interviews.
- The C-CAT team completed a contract with New York City, conducting assessments of the communication climate in 49 hospitals, clinics and community-based organizations.
- We established a new Mower Visiting Scholar Program with Ben Gurion University's Regional Alcohol and Drug Abuse Research Center, with support from Drs. Mort and Toby Mower.
