The figures are classified by Primary funding source (i.e. the Federal figures include both projects that are directly funded by the Federal Government as well as those Federal projects passed through another non-federal entity).

Expenditures grew in all years for an all time high of \$311.7M in FY09. Expenditures increased by 3% over FY08 and 39% over the past 6 years (since FY04).

The large increase in expenditures in 2006 over that of 2005 can primarily be attributed to the NIH Regional Center of Excellence Grant, NIH Regional Biocontainment Laboratory Contract and an increase in the FEMA fire related activity.

The large increase in expenditures in 2007 over that of 2006 can primarily be attributed to the continued construction of the NIH Regional Biocontainment Laboratory.
