This presentation of research expenditures is consistent with annual reporting for the NSF Higher Education Research & Development Survey.

FY12 was a record year for expenditures in all broad categories - Federal, Non-federal and Local funding sources.

FY13 marked the 6th consecutive year research expenditures exceeded \$300m.

The change in expenditures for FY13 compared to FY12 is due to the transfer of a major segment of the Colorado State Forest Service to the State of Colorado effective July 1, 2012. This is evident in the Misc. Federal and the State and Local categories. Expenditures for most colleges/units were flat to slightly higher compared to the prior fiscal year.
