Center for Research on the Colorado Economy (CRCE) 2003-04 Biennial Report

There continues to be a large amount of work done by the affiliates of CRCE on research, outreach and graduate education. We are continuing to further integrate our center with other organizations at CSU. Affiliates of CRCE have collaborated with the Colorado Institute for Public Policy on applying for grants and will continue to do so. Our objective is to become a more visible center on campus and make the case that we have primary expertise on economic development for the region and state.

With respect to research, there have been over thirty refereed journal articles by CRCE affiliates in the last three years on a wide range of regional issues. These articles have covered topics such as economic development, land use, forestry issues, open space, the plight of agriculture in Colorado, tax incentives to promote economic growth, brownfield development and recreation. There have also been over thirty publications as conference proceedings, contract reports and other publications.

The outreach performed by CRCE affiliates has been extensive at the state, national and international levels. A large number of presentations have been made to many agricultural groups on land use, agricultural business, marketing and the impact of chronic wasting disease. Affiliates have also made presentations to local policy makers all over the state on a wide range of issues related to economic development. Affiliates have also attended a large number of academic conferences nationally and internationally.

We have been very successful with respect to graduate education over the last three years. There have been eight completed dissertations related to regional issues. Five of these people have tenure track positions at universities and colleges in the U.S. Two students have 100% research positions and one student went back to their home countries. There have also been several masters theses completed. Currently, there are five dissertations underway related to regional economic issues.

The objectives of CRCE for the next two years are:

- To further integrate the center with other entities at CSU
- Continue the production of Ph.D.'s doing research in regional economics
- Enhance website use and range of topics included
