

# **Public Safety & Police Services Annual Report**

**Updated October 2006**

It is the policy of Mesa State College (MSC) to provide for the safety and security of all members of its campus community. The College believes that academic freedom can only flourish in an environment that is free of criminal or other disruptive activity and unsafe conditions. The College is committed to maintaining the campus community as a place of study, work and residence that is free from abuse, intimidation and harassment and where everyone is treated with respect and courtesy. The College will not tolerate criminal activity and will actively pursue internal discipline, criminal prosecution, or both, for all offenders.

The College contracts with the City of Grand Junction Police Department to provide a safe and secure environment for campus community members. Grand Junction police officers enforce federal, state, and local laws and official college policies. The College insists that police officers treat all subjects as individuals and use their access to both college discipline and the criminal justice system benefit individuals and the community as a whole. Other law enforcement agencies can access the College Discipline System at their discretion.

Mesa State College is a state-supported institution of higher education, located on 42 acres within the City of Grand Junction, Colorado. In conjunction with the Grand Valley Board of Education, the college operates two vocational education facilities located in Grand Junction. The Bishop Campus located at 2508 Blichmann Ave and the Industrial/Energy Training Center located at 29 & D Road. The Montrose Center, an MSC satellite campus, is operated within the City of Montrose Colorado. There are no college-recognized fraternity or sorority houses on or off campus.

The Mesa State community contains 5,938 enrolled students, 493 faculty and staff, visiting guests, and members of the public.

## **Reporting of Criminal Activities or Emergencies**

The Grand Junction Police Department, in partnership with the campus community, is responsible for public safety, security, campus parking enforcement, after hours emergency maintenance, and response to law enforcement and emergency incidents. Administrative offices are located at 625 Ute Avenue, with a sub-station located on the campus at 1041 Mesa Avenue. The Department has officers available 24 hours a day and can be reached by calling 242-6707 or 911 for emergencies. The Police Department responds to all campus incidents reported by students, faculty, staff, and members of the general public.

Emergency response for fire, ambulance, or hazardous materials is the joint responsibility of the Grand Junction Fire Department and the Grand Junction Police Department.

**TO REPORT A CRIME OR EMERGENCY:** Members of the campus community should call 911 from campus telephones or from any pay phone on campus. For non-emergency situations, contact the Police Department by telephone at 242-6707.

Members of the campus community are encouraged to report any activity, situation, or conduct that disrupts, adversely affects, or interferes with the function of the College and the pursuit of its educational purpose.

Reports of criminal activity or misconduct by members of the campus community can be made to:

- The Grand Junction Police Department
- Deans of Academic Schools
- Department Chairs
- The College Discipline Officer
- Advisors of Student Clubs
- The Residence Life Discipline Officer
- Administrative personnel of Student Service programs or departments
- Athletic Coaches

For the purpose of making timely warnings and annual statistical disclosures, a voluntary confidential report of any crime can be made to the Vice President for Student Services and Outreach and Dean of Students by any person directly associated with the college. The intent of the Grand Junction Police Department and the Office of the Vice President for Student Services and Outreach and Dean of Students is to provide as accurate information as possible and encourage pastoral and professional mental health counselors to refer persons that they are counseling to report crimes on a voluntary, confidential basis for inclusion in the annual crime statistics.

## **Security and Access to Campus Facilities**

The Mesa State College campus is an open campus with facilities available to students and the public. All academic buildings are unlocked during normal academic hours. Admission to any non-residential facility after hours is limited to authorized persons with a building key or with an after-hours "Building Use Permit." Buildings are secured by custodial personnel, and parking lots and buildings are periodically patrolled by police officers 24 hours a day 7 days a week.

**Residence Halls:** All residence halls on the Mesa State College campus feature electronic controlled access 24 hours a day. Doors are locked and staff are on duty or on call. All visitors in the residence halls **MUST** be accompanied by a resident. Housing and Police Department personnel patrol the Walnut Ridge Apartment complex.

**Maintenance Security:** All mechanical problems that could cause physical harm to the public or members of the campus community are given a priority status. Maintenance personnel can be contacted through Housing at 248-1536 or Facilities Services Staff at 248-1465, during normal business hours; or by contacting the Facilities Services Department by telephone at:

Mesa State College incorporates environmental security design practices in the planning, building and maintenance stages of all physical structures and grounds keeping on the Mesa State College campus. Lighting and visual blockage surveys are conducted on an as-needed basis in conjunction with Facilities Services staff, and inadequacies are corrected as soon as practicable.

### **Grand Junction Police Department Authority**

The Grand Junction Police Department has authority to enforce all federal, state, and local laws as well official policies of Mesa State College as Level I Peace Officers, (CRS 18-1-901). The authority of police officers are limited to the boundaries of the City of Grand Junction or anywhere when in fresh pursuit of an offender, or when called to assist another agency outside the city limits.

The Grand Junction Police Department maintains close relations with all federal, state, and local law enforcement entities. Criminal cases are filed into the Mesa County Courts or alternatively into the Grand Junction Municipal Court. Mesa State College amplifies their available resources through this cooperative effort in order to support a safe, secure environment on campus.

### **Responsibility For Preparation Of This Report**

The Campus Sex Crimes Prevention Act requires institutions of higher education to issue a statement advising the campus community where the law enforcement agency information concerning registered sex offenders may be obtained. For Mesa State College, this information may be requested by contacting the Investigations Section of the Grand Junction Police Department at (970) 244-3568.

The Grand Junction Police Department also prepares a monthly Uniform Crime Report for submission to State and Federal agencies detailing criminal activity occurring on the campus of Mesa State College. The Uniform Crime Reports are public records and may be inspected at the Grand Junction Police Department. For the purposes of this report, the Grand Junction Police Department Records Division prepared all statistics. The Grand Junction Police Department has access to the Colorado Crime Information Center and the National Crime Information Center.

The Grand Junction Police Department Records Division may be reached Monday through Friday, 8:00 am to 10:00 p.m., at 244-3554.

Information for Student Discipline Statistics is generated from: Campus Hearing Officer records, Associate Director of Housing records, and the Vice President for Student Services and Outreach and Dean of Students Office records.

The data for the Annual Crime Report is compiled by the Office of Institutional Research and Assessment.

## **Campus Disciplinary Process**

Members of the campus community are expected to assume responsibility for their conduct and are held accountable for obeying not only civil and criminal laws, but also Mesa State College Student Code of Conduct and Housing and Residence Life Community Standards. Students can face both criminal and college disciplinary proceedings as a result of breaking a criminal law that also violate College policies. Faculty and Staff can face both criminal proceedings and college disciplinary actions through personnel or administrative actions in the same manner. The college disciplinary system can be accessed through the Grand Junction Police Department, the College Discipline Officer, the Residence Life Discipline Officers, Deans, Department Chairs, Residence Life Staff, and administrative personnel.

## **Sexual Assault And Sexual Harassment Policies**

### **College Standards Of Conduct**

Mesa State College attempts to provide a safe, comfortable academic and social environment. However, the campus is a part of society and is subject to the same concerns and problems inherent to that reality. All incidents of sexual assault are condemned by the College and will be dealt with immediately to the fullest extent of the law and the policies of the College.

Mesa State College is a community consisting of students, faculty, support staff, and administrators. The College does not attempt to define all "student conduct." It relies on students to assume the responsibility and obligation of conducting themselves in a manner compatible with the purpose of the College as an educational institution and the community as a place of residence. In addition to college rules and regulations, all students are subject to the same local, state, and federal laws as non-students and are beneficiaries of the same safeguards of rights as non-students. The academic community has a long and cherished tradition of expecting its members to conduct themselves in accordance with the highest standards of personal behavior.

### **Definitions**

**Sexual Assault** -- Inflicting sexual contact or sexual intrusion upon or engaging in sexual penetration with any person without that person's consent. Such conduct is "without consent" when no clear consent is given; when inflicted through force, threat of force, or coercion; or when inflicted upon a person who is unconscious or otherwise without the physical or mental capacity to consent, e.g., when someone is under the influence of alcohol or drugs.

**Sexual Harassment** -- either from a supervisor, co-worker, faculty, staff or fellow student, when:

1. Submission to such conduct is made either explicitly or implicitly a term of an individual's employment or academic status;
2. Submission to or rejection of such conduct by an employee is used as the basis for employment decisions affecting such individual;
3. Such conduct has the purpose or effect of unreasonably interfering with an employee's work performance or creating an intimidating, hostile, offensive work or academic environment;
4. Such conduct stereotypes a gender into a degrading, less than desirable status within

- the work place, creating an intimidating, hostile or offensive environment;
5. Any deliberate, unwanted or unwelcome behavior of a sexual nature or sexual stereotyping, whether verbal, non-verbal or physical;
  6. In addition, the behavior must satisfy these three (3) legal requirements. The behavior must be:
    1. Unwanted;
    2. Unsolicited (prior behavior and dress are not indications of solicitation);
    3. Deliberate (It is important to understand that sexual harassment need not be repeated. A one-time-only offense may constitute harassment.)
  7. Sexual Harassment may include:
    1. Verbal harassment or abuse;
    2. Subtle pressure for sexual activity;
    3. Sexist remarks about a person's clothing, body or sexual activities;
    4. Unnecessary touching, patting, or pinching;
    5. Leering at a person's body;
    6. Constant brushing against a person's body;
    7. Demanding sexual favors accompanied by implied or overt threats concerning one's job, promotions, performance evaluation, grades, etc.;
    8. Physical assault;
    9. Sexual harassment can come from a person of either sex against a person of the same or opposite sex. It can come from peers, supervisors, or subordinates and may be directed toward any of these.

### **What To Do If You Are Assaulted**

**DO:** Victims of a Sexual Assault are encouraged to tell someone in a timely manner, seek medical help, and report the crime. Tell a/an:

- Counselor
- Friend
- Authority Figure
- Parent
- Police Officer -For immediate help and medical attention, dial 911 to reach the Grand Junction Police Department.
- MSC Staff Member -Any Mesa State College staff member will help you to get medical attention and/or report the crime.
- MSC Department Chairs
- MSC Advisors of Student Clubs
- MSC Athletic Coaches
- MSC Deans of Academic Schools
- The College Discipline Officer
- Any Housing and Residence Life Staff member
- MSC Administrative Personnel

**DO NOT:** Medical help is important for your safety after a sexual assault. Until you are examined by a medical professional:

- **DO NOT** shower/bathe
- **DO NOT** douche
- **DO NOT** throw away or wash clothing
- **DO NOT** throw away or wash bedclothes

Remember, it is critical to preserve medical and criminal evidence.

The decision is up to you to pursue criminal and/or college disciplinary charges. All information taken from a victim of a sexual assault is kept confidential.

**Referrals**

Any person may refer a victim or a student suspected of sexual assault and/or sexual harassment to any faculty, staff, or administrative personnel for assistance in filing an incident report with the appropriate authority. In cases of sexual assault/sexual harassment, which involve student-to-student misconduct, the same processes as other violations of the Student Code of Conduct will be followed. Where sexual assault and/or sexual harassment involves staff to student misconduct, the incident will be investigated by the Affirmative Action Officer.

**Medical, Legal, Counseling And Supportive Resources Available For Victims****Medical**

Community Hospital, St. Mary's Hospital and the County Health Department are located within a one-mile radius of the campus. In addition, the College has contracted with Community Hospital to provide a Student Health Center, which is adjacent to the campus. The Student Health Center is staffed by a full-time nurse and a physician or physician's assistant. After-hours emergency services for students are available through the Emergency Room at Community Hospital.

**Law Enforcement/Legal**

Legal options for victims of sexual assault include filing a criminal complaint with the Grand Junction Police Department or civil action against the accused through an attorney. Legal options for victims of sexual harassment include all criminal and civil remedies, as well as filing complaints with the College's Affirmative Action Officer (Barbara Case-King, 248-1266), or with the Colorado Equal Employment Opportunity Commission (EEOC, 248-7329.) Information about community legal services for victims can be obtained through "The Resource Center" 241-0324 and the Mesa County "District Attorney's Victim - Witness Program." 244-3275

**Counseling and Supportive Resources**

Each residence facility is staffed with a Resident Director, Assistant Resident Director and Resident Assistants, who receive training on dealing with alcohol and other drug abuse, sexual harassment and sexual assault. They are familiar with all campus/community assistance resources. Additionally, the Grand Junction Police Department maintains a Victim's Advocate Program, available 24 hours a day, seven days a week. Law enforcement on the scene notifies the Victim Advocate.

**Student Assistance Program (SAP)**

Counseling and Alcohol/Drug Assessment, Information, Treatment, Referral, Education and Prevention --- The College operates a counseling program for all enrolled students, in conjunction with PsychHealth Associates. Initial assessment is done on campus, with referral to PsychHealth Associates, which is located two blocks from campus at 2004 12th Street, Suite 47. PsychHealth Associates is recognized by the courts and the community as providing professional counseling services to victims and perpetrators of sexual assault.

**Brochures/Handouts**

Campus disciplinary policies and procedures are contained in the Mesa State College Student/Housing Handbook. Housing rules and regulations are published and periodically distributed to all residents. These rules and regulations are incorporated, by reference, into the Student Housing Contract. In addition, the Student Assistance Program (SAP) makes a separate brochure for victims of sexual assault and/or sexual harassment available for victims, as well as for all students. Victims will be provided with a copy of the "Helping People Through the Crisis of Sexual Assault" brochure from the Resource Center.

**Relocation and Room Change Policy**

The option to change the living arrangement of the victim and/or the accused is provided through the policies of Housing and Residence Life, as specified in the Student Housing Contract and the Student/Housing Handbook.

**Sexual Assault and Sexual Harassment Educational Programming**

Educational programs to promote awareness of rape and other sex offenses and to comply with the Drug-Free Schools and Campuses Act:

1. The Grand Junction Police Department provides sexual assault/ date rape educational programs for preventative purposes, as well as programs on personal safety and workplace violence.
2. Campus Community --- At the request of student organizations, staff and faculty, campus-wide presentations on sexual harassment, sexual assault, sexuality and alcohol and other drugs are presented for the general public, by the "AWARE Program" (Drug Abuse Prevention and Education) which is a component of the Mesa State College "Student Assistance Program." Each October and March, as part of the National Collegiate Programs, campus presentations are made concerning issues of health, wellness, sexual harassment, sexual assault and alcohol, and other drug abuse.
3. Residence Life --- A variety of educational programming on the subjects of sexuality, sexual harassment, sexual assault, alcohol and other drug abuse, risk-taking, and acquaintance and date rape are presented to residential students by the Residence Life Staff throughout the academic year. These programs are ongoing and regularly scheduled, in both the fall and spring semesters.

During a campus disciplinary proceeding, both the victim and the student accused of sexual assault are entitled to:

- have an advisor or support person present; and
- be notified of the outcome of the proceeding.

Typical sanctions include: housing eviction, warnings, disciplinary probation, suspension, dismissal and expulsion.

### **Alcohol And Drug Policy**

In the State of Colorado it is illegal for any person under the age of twenty-one years to possess, consume, or purchase any alcoholic beverage. Any person under twenty-one years of age who possesses or consumes an alcoholic beverage anywhere in the state commits a crime. A person over the age of twenty-one commits a crime if they provide an alcoholic beverage to an underage person. Mesa State College prohibits the possession of alcoholic beverages on campus-controlled property without valid use permits or permission of the College.

The State of Colorado prohibits the unlawful manufacture, distribution, sale, possession or use of drugs or controlled substances. The College is committed to maintaining a drug-free campus in compliance with federal and state law. As a public institution and state agency, Mesa State College expects all members of the college community to be responsible for their own behavior within the context of federal and state law and college regulations.

Mesa State College is dedicated to instilling positive change in students' lives. The College believes the abuse of alcohol and drugs is counterproductive to this goal and has established campus policies and programs that support the following:

1. Reduced consumption by those who heavily use alcohol.
2. Responsible consumption for those who occasionally drink alcohol.
3. Controlled usage of legal over-the-counter or prescription medications for medical benefit only.

### **Crime Prevention Programs**

**Security and Safety Awareness Campaign** --- This program is designed to make the campus community aware of campus crime and provide information on reporting and implementing self-security to reduce overall campus crime. Self-help tips and reporting information is provided through posters, brochures and media advertising.

This campaign is provided in the fall and the spring semester.

**Operation ID** --- This service is provided as an effort to reduce the number of thefts and burglaries in the residence halls and aid in the recovery of stolen property. Resident students can have their Social Security Number engraved on personal items they bring onto campus. A Grand Junction Police Department staff member is available to engrave and register serial numbers throughout the school year after normal business hours. Non-resident members of the campus community can obtain this service at the Grand Junction Police Department during normal business hours. This service is provided on a year round basis.

**Campus Escort Service** --- During the hours of darkness, the Grand Junction Police Department, using student volunteers, will escort students to on-campus housing or vehicles parked on campus, on an as-needed basis. Requests for escorts should be made by dialing 260-2683 or 256-5253. This service is provided during the spring and fall semesters only.

**Emergency Contact Service** --- The Office of the Vice President for Student Services and Outreach will serve as the primary referral point for students who need to be contacted due to an emergency. Although any campus personnel are free to deliver emergency messages to students when expedient, the Vice President for Student Services and Outreach Office would like to be informed in order to assure appropriate follow up and documentation.

Determining messaging for "emergencies" while students are in class will be handled on a case by case basis. It is important to note that we cannot guarantee a contact with any student due to their highly mobile behavior, but a good faith effort will be made. Keep in mind that we will not become a messaging service for non-emergent situations.

Depending on the type of emergency, a message will be delivered to the faculty member or work supervisor asking for the student to be dismissed and to:

1. Immediately contact the source of the message or;
2. Immediately proceed to the Dean of Students' office for pertinent information.

**Public Safety Education Service** --- Informative classes and mini-programs are presented by the Grand Junction Police Department throughout the school year. Subjects ranging from personal safety and property security to personal conflict situations are available for campus residents through the Housing Department and for the campus community at large by contacting the Grand Junction Police Department Community Relations and Crime Prevention Division at 244-3587. Fire safety and emergency procedures are available through the Housing Department for residents and through the Grand Junction Fire Department for the campus community.

**Bicycle Registration Program** --- Members of the campus community are encouraged to register their bicycles with the Grand Junction Police Department. Registrants receive a bicycle license from the City of Grand Junction with an identifying number and the bicycle serial number is filed with the department.

**Blue Phone Program** --- Emergency telephones are strategically placed in three locations on-campus. When activated, the phones provide a direct connection via a 911 line to the regional communications center. When the phone is in use, a blue strobe light is activated which not only calls immediate attention to that particular area, but also assists emergency responders for a more direct response.



**Whistle Stop Program** --- The program was implemented in 2001 to provide students, faculty and staff with a means to bring immediate attention should they find themselves in a situation they perceive as threatening. Whistles are provided free of charge as well as training as to when usage would be appropriate. Training is also provided that instructs anyone hearing a whistle to immediately activate the emergency response system by dialing 911 to provide responders with a location, as well as other pertinent information which may assist in identification and subsequent prosecution should the situation warrant it.

### Notice Of Crimes On Campus

Mesa State College is aware that the campus community is entitled to be informed of serious criminal activities on the campus, which pose a continuing threat to the personal safety of members of the campus. Although the specific details of a criminal activity will not be released to the public, if a continuing danger exists, advisory statements will be issued by the Grand Junction Police Department to help prevent the re-occurrence of similar crimes.
